Darbon Institute Launches Online MGC Course



Australia's Darbon Institute announces Male Genital Cutting 101, the world's first online course created specifically for health, mental health, and sexology professionals anywhere in the world who want to better understand and support clients affected by penile circumcision. The self-paced online course

requires roughly 8 hours of study and includes two non-graded reflective exercises. Those who complete the course will be eligible to receive client referrals from The Darbon Institute.

Harms of the Current Global Anti-FGM Campaign

The *Journal of Medical Ethics* recently published a critical essay by cultural anthropologist Fuambai Ahmadu and 25 co-authors titled **Harms of the current global anti-FGM campaign**. The article highlights "a troubling double standard" found in "mainstream media coverage of 'FGM', (where) one would never know that the custom does not selectively pick on women. Almost without exception, wherever there are female genital modifications, the local social norms regarding genital alteration are gender inclusive or gender equal and approvingly call for male genital modifications as well."
